# Koombana Bay Sailing Club Regulations

#### 1.0 Power to Create Regulations

Extract from the Constitution:

#### 27.0 Regulations

- 27.1 Regulations may be prepared to govern the day to day operation of all or part of the Association and shall come into effect after being made available to club members for comment for a period of 28 days and subsequently being adopted by the Board of Management taking into account any submissions resulting from the comment period.
- 27.2 Regulations may be prepared to cover, but not limited to, such matters as:
  - a) Dress standards;
  - b) Uniforms;
  - c) Flags for Flag Officers;
  - d) Etiquette;
  - e) Club fees and charges;
  - f) Parking;
  - g) Boat storage;
  - h) Security.

#### 27.3 Regulations shall state:

- a) The purpose for which they are created;
- b) The members to which they apply;
- c) The privileges and obligations imposed by the Regulation.

## 2.0 Purpose for Which the Regulations are Created

- 2.1 These regulations have been created to:
  - a) Contribute to a sense of belonging and comradery amongst members.
  - b) Recognising those in the club that have accepted responsible positions identified in the club constitution.
  - c) Provide clarity around the dress standards which are expected of club members in specific situations.
  - d) Detail Club Burgees and their use.
  - e) Detail the Club Badge and its use.

#### 3.0 Members to which the Regulations Apply

3.1 These regulations apply to all members of the club.

#### 4.0 Dress Standards

4.1 **The Undress Uniform** of the Club shall be a navy blue reefer coat with black anchor buttons, worn over a long sleeved white shirt with Club tie, light grey trousers and black shoes and socks. Yachting cap (optional) shall be black with Club badge. This uniform is intended to be worn on formal occasions.

#### 4.2 **Day uniform** shall be either:

- a) A white short or long sleeved shirt with two pockets and shoulder straps for epaulettes worn with either white trousers or shorts of an appropriate design, white belt, white shoes, long white socks (with shorts) and white covered yachting cap (Optional); or,
- b) A white short or long sleeved shirt with two pockets and shoulder straps for epaulettes worn with navy blue trousers or shorts of an appropriate design, white belt, white shoes and short socks.
- 4.3 **Acceptable Attire** shall be worn by all members of the club and visitors to the club while on club premises or while representing the club and shall consist of:
  - a) **Generally**: Smart casual attire or workwear specific to activities undertaken within the club.
  - b) **Immediately before and after club activities**: Appropriate sporting attire.
  - c) **Footwear** must be worn in the clubhouse. Bare feet are acceptable on the club lawn and in the sailors bar.

## 5.0 Burgees

- 5.1 **The Club's burgee**; shall be a royal blue pennant with gold cross with an upright entwined gold anchor in the upper canton at the hoist and shall be at least two hundred and thirty millimetres by five hundred and thirty millimetres.
- 5.2 **The ensign of the Club**; shall be the red ensign of the Commonwealth of Australia. The Commodore's flag;
- 5.3 **The Commodore's flag**; shall be the Club's burgee swallow-tailed.
- 5.4 **The Vice Commodore's flag**; shall be similar to the Commodore's with one white disc in the lower canton. The Rear Commodore's flag;
- 5.5 **A Rear Commodore's flag**; shall be similar to the Commodore's with two white discs in the lower canton.

- 5.6 **A Past Commodore's flag**; shall be similar to the Commodore's with a white cross in the lower canton.
- 5.7 No officer's flag shall be displayed on any yacht in the absence of the officer concerned.

## 6.0 Club Badges

- 6.1 **The Club badge** shall be the Club burgee, surrounded by a gold laurel wreath and surrounded by the letters K.B.S.C.
- 6.2 Badges of Rank shall be as follows:

Commodore, four bands with curl;

Vice Commodore, three bands with curl;

Rear Commodores, two bands with curl;

**Past Commodore** (having served at least 9 months), four bands without curl; Secretary, Treasurer and Board of Management member, one band with curl.

- 6.2 **Badges Undress Uniform**: The bands shall be in black with the button of the lower band placed 60 millimetres from the cuff and worn on both sleeves. Bands shall be 12 millimetres wide.
- 6.3 **Badges Summer Day Uniform**: The bands shall be in black on a white epaulette worn on each shoulder strap, above the letters K.B.S.C. The bands shall be 6 millimetres wide with 3 millimetre space between each, with the lowest placed 6 millimetres above the lettering.
